AUTHOR grants to PUBLISHER the non-exclusive right to archive the WORK online and to publish, distribute, and sell electronic and/or print versions of the WORK including but not limited to a Publisher's Anthology. (Electronic versions defined as digital productions of the WORK including but not limited to CD, PDF, online, via e-mail, and electronic versions commonly referred to as ebook or electronic book formats.)

In the event the WORK later appears in another publication, the PUBLISHER requests written credit as the first publisher.

AUTHOR'S WARRANTY

AUTHOR warrants that he/she is the sole author of the WORK, and agrees that PUBLISHER may edit submissions and author's bio according to APA Style and conventional grammar, spelling, punctuation, and usage rules. Content edits will not be made without consultation. Standard English usage will not, in most cases, be applied to poetry.
2. AUTHOR warrants that this work does not infringe on any copyright, trademark, or other intellectual property rights, or violate any laws.
3. AUTHOR grants PUBLISHER the right to use WORK and AUTHOR'S bio as provided in this document for marketing purposes, including but not limited to social marketing, print publications, and online advertising. Glassworks is a nonprofit magazine and will not, in any way, profit from the use of these images or writings.
